

- The Council’s accounting statements were not approved by the statutory date. The Accounts and Audit Regulations require the accounts to be approved by 30 June each year.

Other matters not affecting our opinion which we wish to draw to the attention of the council:

- The Council must ensure that it fully explains variances of +/- 15% in boxes 3, 4, 5, 6, 9, and 10. The increase in box 9 of £27,500 was not explained in 2009/10. This increase was less than the increase in box 6 of £52,082 for the recreation ground project.
- The responses to the trust fund questions in section 1 should be “No” with an “N/A” response to the question in section 2 if the Council are not sole trustees for trust funds or trust assets. This will ensure consistency with the internal auditor’s response in section 4.
