The above named Order, made on the 27th day of October 1981 is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order by the Hampshire County Council.

The effect of the Order, if confirmed without modification, will be to divert the public rights of way described in Part I of the Schedule hereto to the routes described in Part II of the Schedule.

Copies of the Order and Map contained in it have been deposited at the office of the Secretary and Solicitor, Test Valley Borough Council, Council Offices, Beech Hurst, Weyhill Road, Andover, at Michelmersh Post Office, Michelmersh, Romsey and at the office of the undersigned, where they may be inspected free of charge during the normal office hours.

If you wish to have sent to you in due course a notice to the effect that the Order has been confirmed, and a copy of the Order as confirmed, you should write to the undersigned giving your name and address to which these documents may be sent.

Compensation for depreciation or damage in consequence of the coming into operation of the Order is payable in accordance with Section 121 (2) of the Highways Act, 1980, to which reference should be made.

Any representation or objection with respect to the Order may be sent in writing to the undersigned before 11th December 1981 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Hampshire County Council may instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any objections and representations which have been duly made and not withdrawn will be transmitted with the Order.

## SCHEDULE

### PART I

#### Description of Sites of Existing Paths

Those parts of the Footpaths in the Parishes of Michelmersh and Braishfield in the Borough of Test Valley shown on the Definitive Map of Public Rights of Way prepared under Part IV of the National Parks and Access to the Countryside Act, 1949 as described below:-

#### A. Michelmersh Footpath No. 12

The entire length of the footpath which commences at a junction with Road U67 and runs eastwards for approximately 520 metres then generally southeastwards for approximately 416 metres then eastwards for approximately 606 metres to the parish boundary. A total distance of approximately 1,542 metres.

#### Braishfield Footpath No. 5

The entire length of the footpath which commences at a junction with Road U65 and runs westwards for approximately 60 metres to the parish boundary to connect with the eastern end of the path described in Part IA of this Schedule.

### PART II

#### Description of Site of Alternative Highway

#### A. Michelmersh Footpath No. 12

A 3 metre wide farm track which commences at a junction with Road U67 and runs generally eastwards for approximately 292 metres then across Road U67 east-northeastwards for approximately 270 metres then continues northeastwards on a 3 metre wide earth path through woodland for approximately 173 metres then southeastwards for approximately 18 metres to a stile then northeastwards on a 1.8 metre wide headland grass path for approximately 381 metres then north-northeastwards for approximately 56 metres to a stile and field gate. A total distance of approximately 1,190 metres.

#### B. Braishfield Footpath No. 5

A 1.8 metre wide headland grass path which commences at the northern end of the path described in Part IIA of this Schedule and runs northeastwards on the east side of a hedge for approximately 166 metres to connect with Braishfield Footpath No. 6.
