

Minutes of the Meeting of the Braishfield Parish Council held at the Women's Institute on Monday 6th March 1972 at 8 p.m.

Apologies There were none.

Minutes The minutes of the meeting held on Monday 7th February were read & approved.

Matters Arising

- (i) The Clerk read a letter from the Divisional Planning Officer regarding Brook House & Four Winds. The situation was being kept under review at Brook House & the R.D.C. were taking action against Four Winds.
- (ii) The Clerk read a letter from Mr. Waddell, the Clerk of the R.D.C., saying that the Local Authority would notify Parish Councils of applications when they were told to do so.
- (iii) A letter was read from Mr. Bennett, the Divisional Surveyor, saying that the purchase of land was held up in the footway

- but that it should be completed in the next financial year.
- (iv) It was reported that Mr. Watkins had erected a fence between the Recreation Ground + his property.
 - (v) Mr. Musselwhite had given an estimate of £35.50 for repairing the bus shelter.

Correspondence

The Clerk reported that he had received a letter from Mr. Dingwall saying that he wanted 1 minute's silence in memory of the people of Aldershot on Sunday 14th 4th. The Clerk had taken no action because the notice had arrived too late.

Report of the Meeting of the Romsey & Stockbridge Association of Parish Councils held on Monday 14th February, 1972.

Messrs. A. Cobbold & G. Parsons attended & said that they had an interesting meeting. Mr. Wright of the Hampshire River Authority gave a talk on Pollution. They also reported that Ringwood would remain in Hampshire; Parish Councillors would also be elected for 4 years in future.

Any Other Business

- (i) The Clerk reported that he had received a complaint that Mr. Watkins had been panel beating at unreasonable hours. The Clerk was instructed to have a quiet word with him. It was also reported that he was parking cars for people in the village.
- (ii) The Clerk reported that the appeal by Mr. K. Foreman had been dismissed.
- (iii) Mrs Bacon said that she thought

the Litter in the Recreation Ground was very bad. Mr. Parsons said that he would have a word with Mr. Charlie Hans, the foreman at the tip, to see if he could help. The Council were most concerned about the Litter in the village & that this must be rectified.

- (iii) It was reported that the parking of cars in Hill View Road was now very bad because there were so many. It was decided to bring this up at the Annual Parish Meeting & the Clerk was asked to have a word with the local police. Mr. Brown said that he would have a word with the R.D.C. surveyor to find out if anything could be done.

There being no further business, the Chairman closed the meeting.
