

Meeting of Braishfield Parish Council held at the Village Hall Braishfield on Monday 16th April 1984.

PRESENT:

100 APOLOGIES

Apologies for absence were received from the Chairman and Councillor Wyss.

101 MINUTES

The Minutes of the Meeting held on 12th March 1984 were agreed as a correct record.

Minute 93 (relating to Minute 87 of 13th February 1984 - Repair and Resiting of Bus Shelter)

It was reported that Mr. Lalonde had offered to remove the concrete standing left following removal of the bus shelter, and make good.

RESOLVED:

- (i) That the Chairman be requested to liaise with Mr. Lalonde regarding the removal of such parts of the standing which could be mutually regarded as superfluous, and report back.
- (ii) That Wilts and Dorset Motor Services be requested to transfer the bus stop sign to the new site of the shelter.

Minute 97 - Village Pond

RESOLVED:

That the Clerk be requested to submit a formal application for grant aid to Hampshire County Council in addition to the application already made to Test Valley Borough Council.

(i) Extension - 22 Hillview, Braishfield

RESOLVED:

RESOLVED:

That no objection be raised to the proposal provided that appropriate screening is provided.

RESOLVED:

RESOLVED:

That the notice of resignation be received with regret and that the Clerk be requested to make appropriate arrangements for advertising the impending vacancy.

106 HIGHWAYS MATTERS - SUGGESTED SIGN

The Parish Council considered the suggestion made at the recent Annual Parish Meeting that a sign be erected requesting drivers to drive slowly through the village. In view of the probable cost of the sign and the limited effect which it was likely to have, it was

RESOLVED:

That no further action be taken in the matter.

107 RECREATION GROUND - SEATS

Pursuant to Minute 89 of 13th February 1984, the Chairman reported receipt of an estimate of £200.00 total for the supply and paving beneath the seats from Mr. M. Stickley.

RESOLVED:

That in view of the cost involved, the Chairman and Vice Chairman be requested to investigate other possible means of alleviating the problem of mud accumulating under the seats.

108 WATER SUPPLY - ALLOTMENTS

It was reported that a request had been made for the Parish Council to give consideration to assisting in the cost of providing a water supply to the allotments at Braishfield.

RESOLVED:

That the Clerk be requested to contact the owner, through his agent Mr. Lalonde, with a view to the Parish Council assisting with the reasonable installation costs of providing a water supply to the allotments at Braishfield, provided that the maintenance costs are met by the allotment holders.
